Attendance Matters



Welcome to our attendance newsletter of the academic year. Our whole school attendance target is 96%.

This target is based on the government expectations for school attendance.

However, our attendance for last academic year was 93.4% and our current whole school attendance is 90.7%.

We need to improve this to reach our target and ensure your child has the best life chances for the future.

At Sigglesthorne CofE Primary Academy, we know the importance that regular attendance has on your child's learning and well-being; and that having good attendance is directly linked to raising achievement and develops skills for life and work. Regular attendance enables pupils to adapt better to routine, schoolwork, and friendship groups. Therefore, we kindly ask that parents/carers support the school by ensuring that your child attends school every day and arrives ready to learn and on time.

BY LAW, ALL CHILDREN OF COMPULSORY SCHOOL AGE MUST RECEIVE A SUITABLE FULL TIME EDUCATION. YOU AS THE PARENT OR CARER, ARE LEGALLY RESPONSIBLE FOR MAKING SURE YOUR CHILDREN ATTEND ON A REGULAR BASIS. THE DEPARTMENT OF EDUCATION (DFE) PROVIDE INFORMATION FOR SCHOOLS AS TO WHAT IS ACCEPTABLE AND WHAT IS NOT WITH REGARDS TO ABSENCE.

EXAMPLES OF REASONS THAT WILL NOT BE ACCEPTED: BIRTHDAYS, SHOPPING AND DAY TRIPS, ILL SIBLINGS SO ALL CHILDREN STAY OFF SCHOOL, NOT HAVING UNIFORM READY TO WEAR OR UNABLE TO FIND COAT/SHOES ETC, HOLIDAYS DURING TERM TIME.

YOU MAY BE FINED OR PROSECUTED IN COURT.



PERSISTANT ABSENCE IS DEFINED BY THE GOVERNMENT AS ATTENDANCE BELOW 90%. IF A CHILD'S ATTENDANCE DROPS BELOW 90% THIS COULD LEAD TO THEM BECOMING A SAFE-GUARDING CONCERN AND ALSO RESULT IN THE AUTHORITY TAKING LEGAL ACTION.

IF YOUR CHILD IS BELOW 90% YOU WILL HAVE BEEN INVITED
TO ATTEND AN ATTENDANCE SUPPORT MEETING. PLEASE
MAKE SURE YOU ATTEND THIE MEETING. TOGETHER WE CAN
PROVIDE SUPPORT AND HELP YOU TO IMPROVE YOUR
CHILD'S ATTENDANCE.

PUNCTUALITY MATTERS!

We are very proud of the way our children come into school in the morning. Almost of all our children arrive on time. This is very important and encourages good habits of good timekeeping and ensures all children enter a calm classroom environment. Children are expected to arrive at school on time and ready to learn at 9.00am A child who arrives late after the register closes will be marked as late. If a child arrives after 9.30am they will be marked as U. This counts as an unauthorised absence.

ABSENCE THROUGH ILLNESS

We understand that children can become ill and that it is not always easy to decide whether to send them into school or keep them at home. Please see our traffic light reference guide below to support with making this decision. If your child is too ill to attend school, please contact the school office before 09:00 with full details of your child's illness/symptoms. If we do not hear from you, we will ring you to find out why your child is not in school. If we cannot make contact a home visit will be conducted.

Green - Come to school
Coughs, colds, tiredness, sore
throats.
We will always phone you if their

Amber - Seek advice
Headaches, stomach aches.
Children can sometimes feel unwell
for a variety of reasons; call for
advice.

Red - Stay at home Sickness & Diarrhea 48hrs must have elapsed from children's last episode before returning to school

GUIDANCE FOR ABSENCE REPORTING

If your child is going to be absent you must contact the school between 8.00am and no later than 9.00am to let us know the reason why. If no message is received the following procedure will be followed

Day 1: Phone call home.


If there is no answer by 12·00pm we will conduct a wellbeing call to the house to ensure everyone is safe·

We have a duty of care to ensure your child's safety as well as their regular school attendance.

If your child's attendance is below 90% medical evidence may be requested such as appointment text messages or prescriptions.

Mrs Marsden will ring families whose child's attendance is in danger of falling below 90% to offer support and guidance on how to improve their attendance.
